A key element underpinning the reform agenda is the review of the Food Standards Australia New Zealand Act 1991 (FSANZ Act).

The FSANZ Act Review will include a comprehensive examination of the effectiveness of the FSANZ Act and the associated operations and responsibilities of Food Standards Australia New Zealand (FSANZ).

Stakeholders are being asked for their views on the Scoping Paper, which outlines key issues identified with the FSANZ Act and opportunities for legislative and operational reform. Stakeholders will be engaged for their perspectives on the issues and associated opportunities and the impact that these could have.
