

Important privacy information

The Australian Government Department of Health, Disability and Ageing (the department) wrote this information. When you see the word 'we', it means the department.

You can ask for help to read this privacy information. A friend, family member or support person can help you.

We are studying some NDIS supports and things that might become NDIS supports. We are trying to see:

- who they help
- how much they help
- if they are safe.

We want to know if the information we have so far is right. We want to know:

- who uses or might use the supports
- how and why people use the supports
- what other supports people use instead.

How we keep your information safe

Your personal information is protected by law. These laws include:

- the *Privacy Act 1988* (Privacy Act)
- the Australian Privacy Principles.

How we collect your information

We will collect your information when you share your response. We will collect your information through the survey available on the Consultation Hub Website or via email if you email it to us.

What happens if you agree to us collecting your information?

If you agree to us collecting your information, we will use your response to make our assessment of the supports better. We may share all or part of your response within the department.

We will make a summary for the research report of the information that you and other people share with us. We will give this summary to the NDIS Evidence Advisory Committee (the EAC) and its sub-committees. This summary information may also be shared with researchers engaged by the department to develop assessment reports for EAC and subcommittee consideration. The EAC will use this summary to help them make recommendations to Government. If we share your response, we will not share your name. We may post the summary of responses on the EAC website.

The public can read anything posted on our website, including the summary of responses. This includes people who live overseas.

Usually if we share personal information with someone overseas, we have to make sure that person follows our law about personal information. The law we have to make sure they follow is Australian Privacy Principle 8.1.

If you agree that we can share your response, this law will not apply. This means that we will not be responsible if someone overseas uses or shares the information in your response. Your response will not be protected by the Privacy Act. And you will not be able to use the law to ask for compensation.

What kind of information will we collect?

We will ask you to tell us about you and how you use the support. The questions will be a little bit different if:

- you do not use the support
- you are answering for a family member or someone you care for who uses the support
- you are answering as someone who provides the support or researches the support.

The questions could include:

- your disability
- how long you have used the support
- how the support helps you
- any problems you have had with the support.

Information like this is called “sensitive information”.

We will also ask:

- who you think uses the support
- what the support should be compared to
- what the support is used for.

Please do not include information about someone else in your response

If you need to include information about someone else in your response, please:

- do not include the person’s name
- make sure someone cannot guess who the person is from what you say
- tell them about the information on this page
- make sure they agree to us collecting their personal information.
