Partnership Charter

The following document sets out the foundation for how the Lived Experience Partnership Group and National Suicide Prevention Office will work together.

Joint statement of purpose

Working together to ensure diverse lived experience insights and knowledge are embedded in the work of the National Suicide Prevention Office for the shared purpose of improving systems-level responses to suicide.

Principles for partnership

- Value diverse lived experience knowledge and expertise by proactively working to shift traditional power dynamics.
- Ensure group safety by creating a warm, welcoming space where everyone feels treated with care.
- Promote equity and inclusion by investing in the time, energy and resources needed to reduce or remove barriers to participation.
- Demonstrate humility by creating opportunities for others to be involved in the work.
- Practise curiosity by remaining open to other ways of seeing the world and doing things.
- Express generosity to people with different views by deferring judgement to deepen your understanding of their perspectives.
- Build trust by prioritising people and relationships.
- Show respect for others and the work by being upfront and honest rather than avoiding conflict or uncomfortable conversations.
