New Aged Care Act Rules consultation – Release 1 – Service list

The Aged & Community Care Providers Association (ACCPA) appreciates the opportunity to provide feedback on the service list as contained within the first tranche of new Aged Care Act rules released for consultation.

ACCPA is the national organisation representing providers of aged care to older Australians, delivering retirement living, seniors housing, residential care, home care, community care and related services.

We welcome the opportunity to have visibility of, and provide feedback on, the new Aged Care Act rules prior to their implementation, to support a well-designed legislative framework. Our feedback is provided in the context of the information available at present and we are yet to see all tranches of rules, including those relevant to Chapter 4 of the Aged Care Bill 2024. We are therefore unable to provide comprehensive feedback on the interdependencies and cohesiveness of the suite of legislation as a whole.

ACCPA's key messages and recommendations are provided below, with specific comments on the draft Rules contained in the attached appendices.

1. Residential care service list components

- **R1** Increase funding for residential aged care providers to ensure they are adequately funded to meet the new requirements included in the service list and require the Independent Health and Aged Care Pricing Authority to cost and recommend pricing from 2025-26.
- **R2** Establish transitional arrangements so that providers have adequate time to take the actions necessary to meet the new requirements (e.g. replacing or acquiring new furniture, recruiting additional staff).
- **R3** Adopt the changes to the residential care service list components outlined in Appendix 1.

We have reviewed the draft residential care service list with the expectation that providers should be funded to deliver all services in the list, and that services should be capable of being delivered in all locations in Australia and in all existing residential care homes.

In this context, we note the service list includes new requirements (some of which we have identified in **Appendix 1**). Providers will require additional funding to meet these new requirements.

It also means transitional arrangements will be required. Some providers will need to source items which have not previously been mandated (e.g. adjustable beds, a visitor chair in rooms, and a recliner chair with arms in rooms) or put in place new services (e.g. for least one social activity each day that is not screen-based, television-based or meal-based).

In relation to the recruitment of staff, the Department will need to consider whether there will be sufficient workers in Australia from 1 July 2025 and ongoing to enable the delivery of services in the service list.

In addition, we are concerned that some of the requirements, as currently written, do not provide the practical flexibility that is needed in the delivery of aged care services. For example, individuals may not need or want particular items, while some items might not be suitable for certain individuals.

Some of the new requirements will require additional aged care workers who could be difficult, if not impossible, to recruit in the current environment of workforce shortages. They may also be challenging to meet on weekends or public holidays (e.g. for tailored recreational programs; and for at least one social activity each day that is not screen-based, television-based or meal-based).

We also recommend the following changes:

- It should be made clear that providers are not required to provide personal preference items or customised items.
- Requirements in relation to higher everyday living fees (currently additional services or extra services) should be excluded as these items are not required to be provided.
- Access to internet or Wi-Fi should be encouraged, but not required as it is both problematic (intermittent) in some areas in Australia and it can be expensive to put in place due to the infrastructure required.
- Adding 'where practical' to the flexible mealtimes provision, as in reality some providers may not be able to provide meals at any time of the day or night.
- It should be made clear that individuals will need to reach an agreement with the provider, in consideration of work health and safety and other individuals, before bringing any furniture items into the residential care home, as not all items will be able to be accommodated safely.

For specific feedback on items in the residential care service list, please see Appendix 1.

2. Home care service list components

- **R4** Ensure service providers are resourced for transition.
- R5 Ensure the rules adequately describe staff roles, person-led care, risk management and assessment, nursing service types within a multidisciplinary approach to home support care management, and delivery of self-management.
- **R6** Ensure the rules support and advance the rights-based legislative framework established by the new Aged Care Act.
- **R7** Consult on the service types defined in the service list prior to finalisation of the legislation and rules.
- **R8** Adopt the changes to the home care service list components outlined in Appendix 2.

We note that the home care components of the service list also include new requirements. Providers will need to receive additional funding to be able to meet the new requirements and undertake the transitional arrangements required.

The proposed rules reflect a reduction in detail relative to existing legislation. It is essential that the following critical issues are addressed prior to the finalisation of the aged care service list rules for home care.

• Description of care management (section 34) and nursing care (section 41) have been overly condensed, eliminating important descriptors, however there are more detailed descriptions within the transitional care section (section 33, item 1). As the

processes involved in care management, and clinical care – whether for transitional, ongoing support, or reablement – are largely consistent, the detail in the rules should also be consistent.

- There are defined tasks listed within the care manager's role which should be extracted from care management and classified as a specific service type provided by a care manager or similarly qualified professional. These services, including support and education, advocacy and individual requested carer support, should be claimed as outputs in the service list.
- Given the more flexible nature of self-management under Support at Home, it is essential that the rules clearly outline the care manager's responsibilities to help ensure providers maintain high-quality care management and mitigate any unintended consequences of this change. Recommendations for change are included in **Appendix 2**.

There is a need to revisit the rules to ensure that rights-based approaches are incorporated throughout and consistent with primary legislation. For example, referencing individual-led care management or describing rules relating to selfmanagement.

ACCPA is also concerned that the service types were not specifically consulted on with the sector prior to appearing in the rules and we therefore recommend a further round of consultation following receipt of feedback on the rules.

1 Name

This instrument is the Aged Care Rules 2024.

2 Commencement

Note: The following expressions used in this instrument are defined in the Act:

- (i) registered nurse;

In this instrument:

Act means the Aged Care Act 2024.

allied health assistant means a person who holds a Certificate IV in Allied Health Assistance from a registered training organisation within the meaning of the National Vocational Education and Training Regulator Act 2011.

allied health profession means a health profession other than the following:

- (a) dental practitioner;
- (b) medical practitioner;
- (c) midwife;
- (d) nurse.

allied health professional means a person who is registered under the National Law in an allied health profession.

AT-HM List means the Assistive Technology and Home Modifications List published by the Department, as existing on [date of commencement of this instrument].

base efficient price, for a funded aged care service: see Part 4.

base unit price, for a funded aged care service: see Part 4.

CHSP is short for the program known as the Commonwealth Home Support Program.

diverse cultural activities includes cultural activities for the following:

- (a) Aboriginal or Torres Strait Islander persons;
- (b) individuals from culturally, ethnically and linguistically diverse backgrounds;

health profession has the same meaning as in the National Law.

health professional means a person who is registered under the National Law in a health profession.

higher everyday living agreement has the same meaning as in section 284 of the Act.

in a service group: a funded aged care service is *in a service group* if the service is in a service type that is in the service group.

Note: See Part 4.

loading amount, for a loading type that applies to a funded aged care service, means [to be confirmed].

loading type: see subsection 31(2).

medical practitioner means a person who is registered under the National Law in the medical profession.

MPSP is short for Multi-Purpose Service Program.

NATSIFACP is short for the program known as the National Aboriginal and Torres Strait Islander Flexible Aged Care Program.

non-clinical wraparound service, for the supply to an individual of a product listed in the AT-HM List, means any of the following:

- (a) setting up, fitting or providing training on the use of the product;
- (b) providing support and troubleshooting to minimise abandonment of the product;
- (c) maintenance and follow-up for the product (including evaluating the effects on functioning);
- (d) for a product for which the supply basis is loan or rental—refurbishment or disposal of the product at the end of its safe working life.

occupational therapist means a person who is registered under the National Law in the occupational therapy profession.

TCP is short for Transition Care Program.

6 References to actions or statements by health professionals

In this instrument, a reference to an action taken or a statement given by a health professional is a reference to such actions or statements that are within the health professional's scope of practice.

11 Cost

For the purposes of the definition of *cost* in section 7 of the Act, the cost for the delivery of a funded aged care service to an individual by a registered provider means the price charged to the individual by the provider.

18 Final efficient price

(1) This section is made for the purposes of the definition of *final efficient price* in section 7 of the Act.

Services for which subsidy basis is efficient price

- (2) The final efficient price for the delivery of a funded aged care service for which the subsidy basis is efficient price to an individual on a day is the sum of:
 - (a) the base efficient price for the service on the day; and
 - (b) the loading amount for each loading type that applies to the service on the day.

Services for which subsidy basis is unit price

- (3) The final efficient price for the delivery of a funded aged care service for which
 - the subsidy basis is unit price to an individual on a day is the sum of:
 - (a) the base unit price for the service on the day; and
 - (b) the loading amount for each loading type that applies to the service on the day.

- Note: The category residential care is a provider registration category (see paragraph 11(3)(a) of the Act).

 - (ii) any specialist aged care program under which the service type can be delivered; and
 - (iii) whether the service type can only be delivered under a specialist aged care program; and
 - (iv) each provider registration category under which the service type can be delivered; and
 - (d) this Part specifies, for each service mentioned in paragraph 8(1)(g) of the Act:
 - (i) the means testing category for the service; and
