Since the restriction's on the HCP was introduced January 2023, the elderly at home have been financially strained and going without due to medication, medical, etc being more important for health, this forcing the elderly to go without.

This new act the Minister is trying to force through will make life worse for the elderly and their carers and that's if an elderly person has a carer.
